




CONFLICTED GRIEF =

MEDICAL BILLS - FINANCIALLY DRAINING



ESTATE PREP AND PLANNING

Update your will and beneficiaries

Create a "Memorandum of Distribution" (formally or informally)

Name a successor/alternate personal representative/executor

Name a successor/alternate Trustee

Communicate - where your documents are and how to access

Organize, audit, consolidate paperwork and accounts

Add names to accounts, car titles (have joint ownership)

Update MDPOA + successor/alternate

Update POA + successor/alternate


Discuss "what ifs" and "worst case" scenarios regarding your health and finances


Downsize

<u>Probate</u>: The legal process by which a deceased person's assets are distributed after death. <u>Probate is also known as estate administration</u>.

<u>Personal Representative:</u> The person appointed by a Colorado court to administer a probate estate.

<u>Intestate</u>: A decedent died without a will.

<u>Testate</u>: A decedent died with a will.


MEET WITH AN ESTATE ATTORNEY


BE AWARE OF INITIAL EXPENSES (funeral, attorney, reception)




OBSTACLES
